Myth 4 – Green parts don't fit properly.

Green parts are sourced specifically for a precise fit and undergo rigorous quality checks for compatibility, backed by certified technicians.

Myth 5 – Green parts are old and outdated

Green parts are thoroughly refurbished and tested to meet current quality and safety standards. Many are newer models that have been salvaged, often showing less wear than older parts.


Myth 6 – Green parts compromise safety

Myth 7 – There's no warranty on green parts

Many green parts come with warranties – a minimum of 12 months where our recommended partners are used. All repairs carried out via our approved repair networks are also guaranteed for as long as our customer owns the vehicle.
