These are undamaged parts sourced from other vehicles and by using them, we aim to deliver efficient, eco-friendly, and cost-effective repair solutions – especially for customers using our approved repairer networks.

Our Approach to Green Parts

Our approved repairers exclusively use original manufacturer green parts that have been reconditioned to meet strict quality standards. This ensures they are as reliable as new parts and fit each vehicle type perfectly.

If a vehicle is repairable, we may opt to use green parts that align with the industry definition. These parts are:

- Original Equipment Manufacturer (OEM) parts
- Traceable to the donor vehicle
- Non-structural or not safety-related
- Accompanied by a certificate of conformity

Additionally, we exceed the industry standards by requiring that any green part supplied is the same age as or newer than the customer's vehicle.

All repairs conducted by our approved repairer network – regardless of whether green parts are used – are guaranteed for the duration of our customer's ownership of the vehicle. Using our approved repairer network ensures effective management of repair times, costs, and overall quality.





We partner with top vehicle dismantling and recycling experts, SYNETIQ and Green Parts Specialists. We encourage our approved repairers to obtain green parts from our partners, who adhere to strict standards to ensure the delivery of high-quality used Original Equipment Manufacturer (OEM) green parts.

They use Vehicle Identification Number matching to guarantee compatibility and traceability to the donor vehicle, protecting warranties and enhancing vehicle safety by ensuring the right parts are used for each vehicle model.
